






"Fall back" marks the end of Daylight Savings time and occurs on Sunday, November 2nd.










TCO Storage Inventory & the EIA












- - October MDIQ = 1/25th of MMIQ
 - November MDIQ = 1/30th of MMIQ
- · MMIQ Max Monthly Injection Qty
 - October = 9% of SCQ
 - November = 5% of SCQ
- **... MDWQ** − Max Daily Withdrawal Qty
- **∴ MMWQ** Max Monthly Withdrawal Qty
 - November = 40% of SCQ
 - December = 40% of SCQ


Upcoming CGT Maintenance

- November 11-13, 2025
- Backhaul through AlexSEG will be reduced to a level between 2,300,000 - 2,550,000 Dth/d
- Please monitor the Daily Capacity Posting for the specific capacity setting each day of the outage

: Alexandria Compressor Station Unit 908

- November 18-20, 2025
- Backhaul capacity through AlexSEG will be set at 2,450,000 Dth/d




TC eConnects Reports

- •• Measurement Detail Report View measurement details for all meters connected to a specified point, including gravity, molecule percent, BTU, flow temperature, and energy quantity
- Delivery Measurement Detail Provides a detailed report for temperature, specific gravity, N2, CO2, meter index reading, MCF, BTU content, Dth. This report is organized by meter.
- Gas Flow Summary Custom report with many available parameters/ filters to show detailed flow information. This is also available in TC eConnects → Flowing Gas → Gas Flow Summary
- •: Operator Confirmation Report Shows what point operator confirmed for a given point
- •• OBA Imbalance Confirmation Shows imbalance quantities and nominated quantities to the balanced point


How to Subscribe to Reports

To subscribe to reports, click 'Reports' in the menu tree → Schedule and View Reports



Subscribe to Reports - Parameters


- The report parameters depend on the type of report requested. The asterisk indicates a required field that must be entered to submit the request.
- Render Format— Allows you to select the format you would like to receive the report. PDF is the default and most widely used.
- ••• Acct Prd/Month Choose the accounting period/ month for the report. You may select from either the dropdown or by date by clicking the calendar icon.
- **Email** Enter the email address that is to receive the report. You may enter a single email or multiple. If multiple emails are entered, separate each email with a comma.
- BA Enter the desired Operator/ Agency name for the report
- Location Select the location for the report. If you'd like to receive multiple locations on a single report, omit entering a location
- Svc Req K Select the Svc Req K for the report. If you'd like to receive multiple Svc Req K's on a single report, omit entering a K





Subscribe to Reports – Recurrence Pattern

- Establish the frequency of report by clicking the 'Recurrence Pattern' checkbox and entering the parameters, then click 'Submit'
- Note: for daily reports
 - Acct Prd 'Yesterday'
 - Recurrence Pattern 'Every day at 1:45pm'
- ••• Note: for final month reports
 - Acct Prd 'Prior Accounting Period'
 - Recurrence Pattern '10th day of the month'



Looking Ahead – Seasonal Capacity Changes

TCO

- ✓ The team continues to monitor storage levels, weather forecasts, and other operational variables to determine when non-firm capacity changes will become necessary.
- Seasonal capacity changes for winter operations typically include increased non-firm receipt & decreased non-firm delivery availability.

CGT

- Effective November 1, the Design Backhaul Capacity through the following internal constraints will be increased by approx. 90,000 Dth:
 - ShelSFG
 - DelhiSFG
 - AlexSEG
 - RayneSEG

Daily Capacity Postings

- Reminder TCO & CGT provide a Daily Capacity Posting, which is posted each business day by 7:30am CT
- ✓ The Daily Capacity Postings illustrate commercial restrictions for the next gas day(s), including non-firm/ secondary availability, AutoPAL limits, etc.
